## USING MN CHOICE

To register for notification about an offender in a Minnesota State Correctional facility, visit the MN CHOICE website at [www.minnesotachoice.com](http://www.minnesotachoice.com).

### Dashboard

Your Dashboard in MN CHOICE is where you can view your most recent notifications, access and update your account information, view agency messages and reminders, or search for an offender.

### Message Center

Your Message Center provides an alternative method for receiving offender notification information. Every secure Message Center notification displays the full letter as if it were mailed to you by the U.S. Postal Service. Each notification contains the date and time the notification was sent and other important information.

### My CHOICE Account

The My CHOICE Account link is where you can update your personal information, manage your notifications, and provide other pertinent information.

### Broadcast Viewer

The Broadcast Viewer allows the Minnesota Department of Corrections Victim Assistance Program a way to help you stay informed by sending you important updates.

## INPUT INTO OFFENDER RE-ENTRY

Minnesota CHOICE offers victims the opportunity to provide a "Re-Entry Statement." The majority of incarcerated offenders will at some point serve their sentence and be released back into society. Usually there is a supervised release period that takes place at the time of release. (This is a period of time when the offender is supervised by a supervising agent or parole agent.) Some victims would like to have the opportunity to provide the professionals who plan for the offender's release information to be considered during this process. Through a "Re-Entry Statement," Minnesota CHOICE offers victims an opportunity to provide this information to the offender's case worker and future supervising agent. Victims can't prevent the release of an offender, but can provide information that might be helpful for the release-planning process.

## VICTIM-INITIATED RESTORATIVE JUSTICE PROGRAMS

Minnesota CHOICE offers victims the opportunity to access information or request to participate in certain Restorative Justice processes.

### These practices include:

- Offender Apology Letter
- Victim-Offender Dialogue
- "Circle" processes such as VOCARE
